All seasonal housing must meet the requirements of the Ontario Building Code and Fire Code.

Failure to meet the Ontario Building Code and Fire Code can result in non-approval, and/or legal action. It is strongly recommended that those building new bunkhouses, renovating existing bunkhouses and/or renovating other buildings (e.g. residential homes) for the purpose of accommodating migrant workers consult the Building Department and Haldimand-Norfolk Health Unit well in advance to ensure permits can be obtained and requirements met before the final inspection for worker approval is conducted.

To avoid delay with your bunkhouse approval, please ensure the following steps are taken prior to inspection:

- The water supply is on and working properly. It is advised to sample the water and obtain a bacteriologically safe result prior to the inspection.
- The temperature inside the bunkhouse is $\geq 20^{\circ}\text{C}$ (68°F).
- The bunkhouse has been thoroughly cleaned.
- Any outstanding requirements issued by the HNHU, Building Division and/or Fire and Rescue Services have been completed.
