**TO: To All Property Owners in Haldimand County and Norfolk County  
Who Have a Primary Residence Outside of Haldimand County and/or  
Norfolk County**

**RE: SECTION 22 ORDER – EFFECTIVE IMMEDIATELY**

---

I, as the Medical Officer of Health, am of the opinion, based on reasonable and probable grounds, that:

1. a communicable disease exists or may exist or there is an immediate risk of an outbreak of a communicable disease in the Health Unit served by me;
2. the communicable disease presents a risk to the health of persons in the health unit served by me; and
3. the requirements specified in this order are necessary in order to decrease or eliminate the risk to health presented by the communicable disease.

Therefore, I am issuing the following Section 22 Order, under the *Health Protection and Promotion Act* (Act), R.S.O. 1990, c.H.7:

1. Subject to clauses (2) and (3) of this Order,
  - a) You are not permitted to occupy your secondary residence within the Health Unit, which includes a rented cottage, vacation home, beach house, chalet, and/or condominium ("Secondary Residence").
  - b) You are not permitted to allow anyone else to occupy your Secondary Residence within the Health Unit.
2. You or someone else may occupy your Secondary Residence if it is necessary to assist with the effectuation of a self-isolation requirement by the Health Unit or if it is necessary to effectuate any orders or directives under the *Quarantine Act*.
3. Prior to you or anyone else occupying your Secondary Residence for the purposes identified in clause (2), you must seek approval from the Health Unit.

**NOTICE**

**TAKE NOTICE THAT you have the right to a hearing before the Health Services Appeal and Review Board in accordance with Section 44 of the Health Protection and Promotion Act. You must mail or deliver a notice in writing requesting a hearing to the undersigned and to the Health Services Appeal and Review Board,**

**151 Bloor St. W., Toronto, Ontario M5S 2T5, within 15 days after this Order is served on you.**

**AND TAKE FURTHER NOTICE THAT** although a hearing may be requested, this Order takes effect when it is served upon you.

**FAILURE** to comply with this Order is an offence for which an individual may be liable, on conviction, to a fine of not more than \$5,000 for every day or part of each day on which the offence occurs or continues.
